AMENDMENT NO. 2
61-2949
To the Subagreement
Between
Michigan State University
And

The Board of Trustees of the University of Illinois

The Subagreement No. 61-2949 between Michigan State University (MSU) and The Board of Trustees of The University of Illinois (LEAD INSTITUTION) for the Dry Grain Pulses CRSP project titled, "Biological Foundations for Management of Field Insect Pests of Cowpea in West Africa," under Prime Award No. EDH-A-00-07-00005 is amended in part as follows:

Article IV. Amount of Subagreement. Delete the first paragraph of the article and substitute in lieu thereof the following:

The total estimated amount of the Subagreement shall not exceed Four Hundred Forty Thousand Two Hundred Thirty Eight US Dollars (US\$440,238.00). Said amount consist of:

30 months approved budget	4/1/08- 9/30/10	\$400,000.00
Host Country Institutional Capacity Building Supplemental Funds for:

MSU has obligated the amount of Two Hundred Forty Five Thousand Eight Hundred Eighty Three US Dollars (US\$245,883.00), as partial funding of the total estimated amount as set forth above. Via this amendment MSU obligates an additional Forty Thousand Two Hundred Thirty Eight US Dollar (\$40,238.00) to be exclusively expended for the purpose of enhancing the capacity of collaborating Host Country institutions. This funding is being provided in response to a proposals that was received (7/25/08) and subsequently approved by the Management Office of the Dry Grain Pulses CRSP following review by the Technical Management Advisory Committee (TMAC).

These funds are to be expended in accord with the budget and conditions specified in the attached Memorandums from the Management Office dated 9/11/2008.

LEAD INSTITUTION may not exceed the total estimated amount or the obligated amount of this Subagreement, whichever is less.

All other terms and conditions of this Subagreement will remain unchanged.
